The duties of the committee shall be as under:

- 1. A complaint from an aggrieved student relating to the institution shall be addressed to the Chairperson of Student Grievance Redressal Committee (SGRC).
- 2. The term of the members and the special invitee shall be of two years.
- 3. In considering the grievances before it, the SGRC shall follow principles of natural justice.
- 4. The SGRC shall send its report with recommendations, if any, to the concerned institution and a copy thereof to the aggrieved student, within a period of 15 days from the date of receipt of the complaint.
